

The LVNBA was founded in 1981 by a group of Black attorneys in an era when it was difficult for Black attorneys to be accepted as members in established bar associations. Today, the LVNBA has grown from a handful of attorneys into a vibrant legal community and represents the interests of attorneys, judges, law professors, and students of African descent who share a common interest in fostering professional development in the legal community and in addressing issues that are important to the African-American community as a whole. The LVNBA is Nevada's only affiliate chapter of the National Bar Association (NBA), the country's oldest and largest predominantly African American bar association. The NBA represents a professional network of more than 20,000 lawyers, judges, educators and law students and has 84 affiliate chapters throughout the United States and around the world.

In 1987, the LVNBA held its first Scholarship Gala, a very successful event that soon became a must-attend event for the Nevada legal community. Through the Annual Scholarship Gala the LVNBA raises scholarship funds each year for law students who are committed to serving minority, low income, and other underserved communities in Clark County, Nevada. Thanks to the generosity of member contributions, community supporters, law firm donations, and corporate sponsors, the LVNBA has been able to award tens of thousands of dollars in scholarships to law students over the past twenty-five years. Our scholarship recipients are employed in diverse settings, law firms, corporations, city and state agencies, as solo practitioners, and as elected officials.
